What is FIRST?

Financial Integrity Rating System of Texas

Created by Texas Education Agency in response to Senate Bill 875 of the 76th Texas Legislature in 1999 and amendments under House Bill 5 of the 83rd Texas Legislature in 2013 to achieve quality performance in the management of school ZijhYji financial resources.

Rating calculations are based on data from the 2022ÿ23 fiscal year.
